WRITING TASK 1

SAMPLE WRITING TASK 2

Nowadays more and more specialists migrate to developed countries from poor ones. People are divided in their opinion whether it is stealing qualified workers by rich countries or it is just a natural movement of such people around the world. Personally I disagree with the idea, that there is any kind of theft towards the developing countries. I will explain my point of view in the following passages.

On the one hand it might seem that some European or Northern American countries strive to attract as many foreign specialists as possible. As a result, poor countries have lack of valuable human resources, which could help them to become rich ones. However, it is not only the rich countries' fault. Lots of poor countries cannot become wealthy because their budget suffers from inappropriate distribution. They often spend a great deal of money on a governmental community instead of encouraging their own specialists by suggesting better conditions. That is why I believe there is no crime in attracting qualified workers by more prosperous countries.

It is universally accepted, that an educated person with significant work experience in his or her

specialization deserves better conditions (e.g. higher salary), than those whose job doesn't require higher education. Unfortunately, such people labour is often underestimated by the poor countries' government, and they are not paid enough. Hence, they start thinking about going abroad to improve their life conditions. I suppose, it is their own choice, and it is a natural movement of such specialists, because they can earn more in those countries that are interested in development.

Though it sometimes believed, that rich countries deprive the developing ones of human resources, because more and more qualified workers leave their motherlands, they are not totally responsible for this. If work conditions do not meet the requirements of people, and they have a chance to improve their lives abroad, it is natural for them to move.
